



For a longer lasting Landfill & to keep our rates low:

- **Sort your waste (use map for ideas of how and what to sort).**
- **Bring different materials separately, or sort as you load it for easy distribution upon arrival.**
- **Use the Recycling Compounds**
 - **Metal (mowers, bikes, BBQ's, wire, appliances, etc.)**
 - **Cardboard, Paper, Plastic (non-film), Tin.**
 - **Electronics**
 - **Paint**
 - **Used oil, oil filters, jugs, & pails**
 - **Batteries (vehicle, household size, rechargeable)**
 - **Propane tanks**
 - **Concrete**
 - **Tires**
- **Wood pile can only take clean wood, no painted, stained, treated, or plywood, particle board, or OSB. Thank you**
- **Compost, no food, plastic, or garbage. Only Grass and Leaves**

Scale Procedures:

- **Take note of the other vehicles (sometimes the attendant is doing something that means you may have to wait)**
- **Stop at the intercom**
- **Provide your account number by showing the card**
- **Provide information of waste in load**
- **Proceed as directed by scale attendant; if unclear please ask for clarification.**
- **After unloading, stop on scale and weigh out. Please wait for attendant to acknowledge you before driving off.**
- **Please follow all directions, this helps reduce extra work for staff as well as helps with safety for all of us.**

Regulations, Policies & Procedures

1. Site users are requested to follow all the policies and procedures of the landfill. These policies are put into place to ensure that the landfill is operated in a safe and environmentally sound manner.
2. The regional landfill uses random load screening to ensure waste is acceptable under the Alberta Environment Waste Control Regulation and other governing regulations for a Class II landfill site. Any vehicles entering the site may be subject to load screening.
3. Prohibited Wastes
 - Liquid Waste (ex. sludge, sewage)
 - Hazardous waste
 - Hospital/biomedical waste
 - Radioactive Waste
 - Explosives & ammunition
 - Ozone depleting substances
4. If you have any other questions or concerns, don't hesitate to call and ask. We want to do our best to keep everyone informed as to what we do and why.

Please let the scale attendant know everything that is in your load for proper disposal and to ensure a safe environment for all involved.

If you are caught dumping in the wrong place, or putting wrong material in an area, you will be responsible for the cost of cleanup and any further costs associated with it, in addition you could be banned from the site. Please follow instructions and signs.
